  - B. Treasurer's Report Jamie McCarthy

#### NOTICE:

- Please read the following hand out from the meeting:

- Because we have had virtually zero financial activity since the June Report, I did
  not run the large spread sheet that I usually have as a treasurer's report. I
  instead have attached June's report on the back of this, so you can refer to it, if
  you have any questions on balances, etc. I will run a FULL report for our next
  meeting, once we have settled issues with dues, audition fees, and participation
  fees.
- 2. Currently, the biggest issue in the "treasurer world" is the proper invoicing of dues/participation fees. Mainly, where that invoice needs to be sent to, who it needs to made out to, and what date it needs to be made out.
  - a. I have asked in the past that if you plan to use Arts in Ed, that you notify me ahead of time. Some districts made this decision late in the season, so they were invoiced as a district, and now need new invoices.
  - b. When I provided these new invoices, we have had issues with dates, because BOCES will not pay an invoice that is dated before you completed the purchase order. In other words if I send out invoices with July 1, on them, and your district does not get around to processing a purchase order until July 31, BOCES won't pay the invoice.
  - c. While I encourage schools to use the arts-in-ed program, because of the aid it will provide to your district, it is getting VERY tricky on my part, to figure out which district is doing what, etc. In the end, it results in MCMEA waiting for their money. For some of our districts, the purchase orders have yet to be processed.
  - d. Attached you will find a mock up invoice, that I think will solve our problem, but I would like your feedback on it.
- 2. The other issue is that I need to know who your "District Contact" is. Some smaller schools do not have department chairs. In some cases we are waiting on payment for participation fees because I am invoicing your district, but it is not necessarily going to the right person. If I could have ONE person from each district email me who their "District Contact" is for this year, I will make sure that all treasurer correspondence is sent to them.
- 3. Lastly, if you are a school that uses an open purchase order, please pay attention to the following. For example one MCMEA PO that covers your dues, auditions, and participation fees, I request that you send a copy to me, and to this year's audition chair. That way your "proof of payment" is already in their hands, and I do not have to run around making copies and sending them before audition deadlines.

Also – Each school please send the name of the Business Office/Administrator that should receive invoices sent from MCMEA to Jamie as soon as possible.

- 1. Prepare and memorize any 5 scales
- 2. The judge will choose 3 for you to perform

#### 6-8 ORCHESTRA

- 1. Prepare and memorize any 7 scales
- 2. The judge will choose 3 for you to perform
- 3. One scale must be performed in 2 octaves

Suggestions for additions to "General Guidelines for MCMEA Adjudicators" on page 3 of MCMEA Handbook

#1. Judges who wish to do so may use a recorder to record prepared materials only (judge to furnish own recorder). This recording is to be used only for the personal reference of the judge to resolve questions concerning ranking.

#2. No one should be allowed in the audition room except the student.

#3. The order of the audition will be:

- 1. Scales/rudiments/required tuning exercises
- 2. Prepared etudes
- 3. Sight-reading

#4. Students are required to perform from memory three (3) one-octave major scale chose from the above prepared scales. A missed note receives <u>no credit</u> for the scale

#5. The following numerical rating will be used:

| Junior High | Senior High |
No scales correct - 0 points | No scales correct - 0 points |
One scale correct - 1 point | One scale correct - 1 point |
Two scales correct - 4 points |
All scales correct - 5 points |
All scales correct - 5 points |

#6. For Etudes, refer to all the categories when deciding on the overall score. Please feel free to use any comments that will help you create your proficiency list.

#7. When administering the sight-reading, please physically point out the time signature, key signature and give the tempo with a metronome. Turn the metronome off and allow each student 1 minute of study time before the tempo is reestablished.

#8. Only allow 2 stops during sight-reading. The audition will terminate at the third stop.

#9. Use the following scale Sight-Reading evaluation:

0 points - Shows no sight-reading ability

1-3 points - Shows little sight-reading ability

4-6 points - Shows moderate sight-reading ability

7-8 points - Shows great sight-reading ability

9-10 points - Near perfect sight-reading ability.

#10. In the event that a student shows up who has prepared the wrong set of etudes, please immediately call for the Audition Chairperson.
